Article 3: To determine and approve compensation, if any, to be paid District officers.

Article 4: To establish a date of the Annual Meeting.

Article 5: To elect five (5) school directors from the nominees to serve on the Kingdom East Unified Union School District Board. (Australian Ballot)

- One (1) school director who is a resident of Concord for a three-year term.
- One (1) school director who is a resident of Lunenburg for a three-year term.
- One (1) school director who is a resident of Lyndon for a three-year term.
- One (1) school director who is a resident of Sutton for a three-year term.
- One (1) school director who is a resident of Wheelock for a three-year term.

Article 6: Shall the voters of the Kingdom East Unified Union School District approve the Board of School Directors to expend \$33,998,997, which is the amount the Board has determined to be necessary for the ensuing fiscal year? It is estimated that this proposed budget, if approved, will result in education spending of \$15,859 per equalized pupil. (Australian Ballot)



Article 9: Shall the voters of the district authorize the Board of School Directors to accept and expend such grant monies as may from time to time become available to the school district?

Article 10: To transact any other school business thought proper when met.
