1. <u>Approval of Meeting Minutes:</u>

Motion made by Martha Feltus, seconded by Kermit Fisher, to approve the minutes of the 6/06/11 meeting as written. Motion carried 2-0.

2. <u>Approval and signing of orders:</u>

The Board approved and signed the orders drawn on the Treasurer for weeks #23 and #24.

3. <u>Highway Report:</u>

At 44% through the year, payroll is 51% expended and the entire budget is 44% spent.

4, <u>Bond Anticipation Note:</u>

The Board signed the Bond Anticipation Note for the wastewater treatment plant upgrade project with the Community National Bank for \$1,500,000 at 1.39% interest.

5. <u>Tax Anticipation Note:</u>

The Board signed the Tax Anticipation Note with the Union Bank for \$1,000,000 at 1.55% interest.

6. Revenue Anticipation Note:

The Board signed the Revenue Anticipation Note with the Union Bank for \$100,000 at 1.65% interest.

7. Delinquent Wastewater Payment Policy:

The Board reviewed the proposed policy for the treatment of unpaid wastewater accounts. The definition of delinquency will be included in the policy.

8. Storm Damage Update:

To date the cost of the May 26-27 storm has been \$68,000.

9. Unlicensed Dogs:

The number of licensed dogs in Lyndon continues to decline. A dog census was performed back in the late 1970's. A public notice will be put into the newspaper reminding residents of the dog licensing requirements.

10. Grader Bids:

Motion made by Kermit Fisher, seconded by Martha Feltus, to accept the bid from John Deere for a new grader at \$208,250, after trade-in of the 1986 grader. Financing is proposed to be a lease to purchase over five years at 3.55% interest. Annual payments are to be \$43,099.30. Motion carried 2-0. Dan Hill will continue to investigate financing options.

11. Other Business:

- Dan met with the police and fire chiefs about high water events. They asked that an ordinance be established to allow for the levying of fines for those going around a barrier and then needing to be rescued. Dan will investigate further.
- The proposed reapportionment plan shows that Lyndon has been split into two districts. The B) BCA will be notified of this.
