#### 1. Approval of Minutes:

Motion made by David Dill, seconded by Marty Feltus, to approve the 8/13/12 meeting minutes. Motion carried 3-0.

2. Approval and signing of orders drawn on the Treasurer for weeks #32 & #33: The Board approved and signed the orders drawn on the Treasurer.

#### 3. Highway Report:

Budget is still in good shape. Will see a difference as the grader payment will be paid this week and paying will start the week of September 10<sup>th</sup>.

### 4. Liquor License Application:

The motion was made by Marty Feltus to approve the 1<sup>st</sup> Class Liquor License application for Lyndonville Restaurant, Inc. dba Lyndon Buffet with the standard conditions, seconded by David Dill. Motion carried 3-0.

#### 5. 2012 Tax Rate:

The motion was made by Marty Feltus to accept all tax rates as set, seconded by David Dill. Motion carried 3-0. The State has set the Homestead School rate at \$1.340 and the Non-Residential School rate at \$1.4187.
