# 3. Bandstand Park Request

Cheryl Mcmahon made a request on behalf of the Chamber of Commerce to use Bandstand Park to hold the Stars and Stripes Festival on Saturday July 18<sup>th</sup>, 2015. Ray Durocher made the motion to approve. Heather Bollman seconded, and the motion carried 4-0.

# 4. <u>Banner Requests</u> Three Banner requests:

The Lyndonville Chamber of Commerce is requesting a banner for the Stars and Stripes Festival from July 9<sup>th</sup>-July 18<sup>th</sup>, 2015.

Burklyn Arts made two Banner requests. They are requesting a Banner for December 4<sup>th</sup> – December 14<sup>th</sup>, 2014 for their Christmas Craft Fair at Lyndon State College. They are also requesting a Banner for June 18<sup>th</sup>-July 4<sup>th</sup>, 2015 for their annual Craft Fair held in Bandstand Park. The 2015 Craft Fair will be held on July 4<sup>th</sup>, 2015. Ray Durocher made a motion to approve all three Banner requests. Ron Aiken seconded the motion and the motion carried 4-0.

Ray Durocher made a motion for the Municipal Administrator to approve future Banner requests that meet the Overhead Street Banners Policy. If there were a banner that was questionable it would be brought before the Trustees. Ron Aiken seconded, and the motion carried 4-0.

# 5. Other

- a. Robert Bigelow was requesting the use of Bandstand Park for a Vintage snowmobile exhibit in Bandstand Park on Sunday, December 21, 2015. As part of the event he was requesting the ability to offer rides with Santa on one of the sleds with a \$5.00 donation to H.O.P.E. The Trustees were fine with the event once the proper paper work is filled out. However, if snowmobile rides were offered on one day, a 1 million dollar liability insurance policy must be taken out by the organizers of the event.
- b. The topic of liability insurance was discussed. The Trustees requested a list of all events that would have the potential for needing an insurance policy. Among the events mentioned were coin drops, Stars and Stripes, Burklyn Arts Festival, and Farmer's Market.

- c. The Trustees directed Justin Smith to get them information on a management agreement, which could be proposed between the Village of Lyndonville and VIS.
- d. Tim Gaskin asked about the removal of the snow banks in the Village.
